The following Kansas City establishments are hereby ordered to cease the sale of alcoholic beverages. No wholesaler may deliver alcoholic beverages to any business on this list. The following businesses are in default with their current city liquor license, have failed to renew their license, have let their license lapse without renewing, have been suspended, or have been revoked.

Chapter 10, Sec. 10-2(a)(2) of the ordinance of the City of Kansas City, Missouri states It shall be unlawful, without first obtaining a license, to manufacture, sell, solicit orders for the sale of, or deliver, at wholesale or retail, alcoholic beverages or allow the consumption of alcoholic beverages in or upon any premises where food, beverages or entertainment are sold or provided for compensation.

Wholesalers on this list are considered unlicensed and are not permitted to make deliveries. Further, no licensee may accept alcohol deliveries from unlicensed wholesalers.
